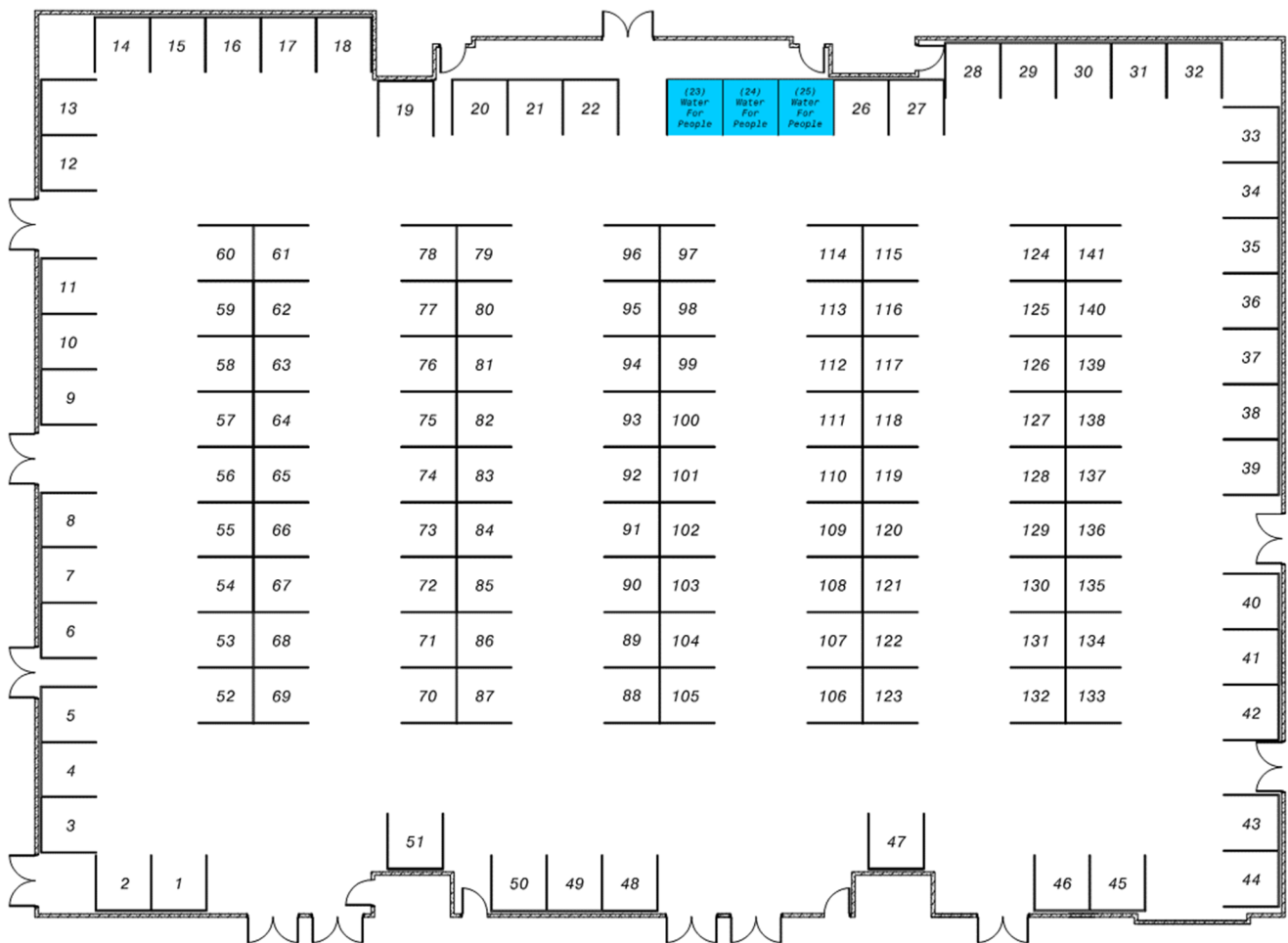


EXHIBIT HALL LAYOUT
